Course Objectives	The purpose of this course is to teach students the definition, history, role, principles, sources of criminal law according to legislation and general theory of crime, typicality and illegality as the elements of crime. In addition, this course aims to teach students the general observations about criminal law, specific provisions, general information about types of crimes, related to the Criminal Code. The course gives detailed information about legal benefits, perpetrator, material and moral element, attempt, gathering and accessory of specific crimes.
Course Learning Outcomes	The students who succeeded in this course; <ul style="list-style-type: none"> • Will learn sources of criminal law, illegality principle and acquire skills in using and interpreting this sources; • Will learn the application field of criminal law rules and extradition; • Will learn general theory of crime, the concept and elements of crime; • Will learn typicality as one of the elements of crime; • Will learn illegality as one of elements of crime; • Will examine the general observations about Criminal Code specific provisions; • Will have general information about International Crimes (genocide, crimes against humanity, migrant smuggling and human trafficking); • Will examine differences between murder and bodily harm within the scope of general theory of crime; • Will have information about crimes of torture and torment, crimes against carnal immunity; • Will learn the crimes which are regulated under the topic of crimes against liberty; • Will learn the crimes of insult and insult to one's memory which are regulated under the topic of crimes against honor; • Will have information about crimes against private life and private fields of life;

	<ul style="list-style-type: none"> • Will examine differences between the crimes of robbery, plundering, fraud and abuse of confidence; • Will have information about crimes against community and crimes against public confidence; • Will learn the crimes against state and nation and cybercrimes.
Course Contents	<p>The course contents are basic principles and liability, sources of criminal law, application of criminal law in the terms of time, place and person, general theory of crime, criminal capacity, intent, negligence, unjust provocation, recidivism, elements of crime, criminal attempt, accomplice ship and joinder of crimes, the crimes against life, physical integrity, carnal immunity, liberty, honor and property which are regulated under the topic of crimes against the person; forgery of documents, crimes against public peace which are regulated under the topic of the crimes against nation; crimes against the reliability and functioning of administrative body and crimes against judiciary which are regulated under the topic of crimes against state.</p>
