Course Objectives	Acquisition of basic and in-depth knowledge in the field of criminal procedure law: students will be acquainted with the criminal procedures (regular, abbreviated, against legal entities) conducted by the courts in connection with violation of legal norms. As a result, the student is expected to acquire theoretical and practical knowledge in the field of criminal procedure law.
Course Contents	Criminal procedure law is a scientific discipline that studies the legal norms that regulate the position and powers of the litigants and other entities participating in the criminal procedure, the type, form and conditions for undertaking the procedural actions that achieve the purpose of the criminal procedure, as and the legal consequences in case of violation of such regulations. The central issue is the criminal procedure before the courts, the term and the case, the basic principles, the regular criminal procedure, the shortened criminal procedure, the procedure against legal entities. The greatest attention is paid to the regular procedure, with its detailed elaboration, starting from the pre-investigation procedure (as a precursor to the formal procedure) up to the phase of legal remedies, including the extraordinary legal remedies. The judgments and practice of the European Court of Human Rights, as well as their impact on the criminal procedure system of the Republic of Turkey are an integral subject of elaboration.
