Course Objectives	Introduction to European foreign and security policy, based on the Maastricht Treaty. Analysis of the basic objectives of foreign and security policy: - protection of the common values and fundamental interests of the Union, - strengthening the security of the European Union, - preserving peace and strengthening international security, - fostering international cooperation, - developing democracy and rule of law - protection and promotion of human rights and freedoms as a fundamental principle The main goal is to strengthen its identity on the international stage, especially through the implementation of a common foreign and security with a special focus on the progressive creation of defense policy.
Course Contents	The course will be divided into three main sections. The first section provides the historical context to help us understand how the Europeans got to where they are. The second section will explore the drivers and preferences of individual European states. The final section will focus on current EU policies and how national preferences and cultural influences manifest themselves in multilateral settings such as the European Union and NATO.
